Specific Agreement of Student Exchange

Celebrated by

Universidad Autónoma Del Estado De Hidalgo (México)

and

Tianjin University of Traditional Chinese Medicine (China)

1. Purpose

This Agreement is intended to strengthen the interaction between Tianjin University of Traditional Chinese Medicine (TUTCM) and Universidad Autónoma del Estado de Hidalgo (UAEH), spread cultural knowledge, and advance the international academic community through the initiation of a student exchange program.

2. Student Exchange

The "Exchange Period" shall be at least one semester, including short-term visits and research. Each institution may nominate two (2) students for the exchange each year, but this number can be amended by mutual consent. Both institutions agree that one student attending two semesters shall be equal to two students attending one semester.

- Any imbalance in the amount of exchange between the two institutions in a given year, or if one institution has no student to be sent, then the other institution receiving exchange students shall charge the tuition fee from the sending institution and give appropriate discount.
- Exchange students shall be subject to the rules and regulations of the Host Institution.
- Neither institution shall be required to nominate or accept students for the Exchange Program.
- Exchange students shall only remain eligible for degrees at their Home Institution and shall not be considered eligible by the Host Institution.
- Exchange students shall be offered guidance and assistance in obtaining housing and other hospitality related issues, but the Host Institution shall not be responsible for providing housing or financial assistance of any kind.

3. Promotional Material/ Advertising

The use of an institution's logo or name shall not be used by the other partner institution without prior written consent, and in accordance with the institution's internal policies.

4. Assessment Period

- All programs, projects or ventures undertaken by Universidad Autónoma del Estado de Hidalgo and Tianjin University of Traditional Chinese Medicine shall be subject to agreed periodic assessment and evaluation, by appropriate representatives of the programs or projects involved.
- The Agreement signed by both institutions shall remain effective for five (5) years.
- The Agreement may be terminated if each party mutually agrees, but there must be at least a six (6) month advanced notice before the intended termination date.
- The Agreement can be amended or renewed by written consent, and must be signed by authorized representatives of each institution.

Two (2) copies of the Agreement shall be signed in English language, and both shall be recognized as formal documents.
